



CART GUARD VSC COVERAGE

When Coverage Begins & Ends:

- Coverage starts on the Agreement Purchase Date and ends at 12:00 midnight on the Agreement Expiration Date (as listed on your Schedule Page).

Exclusionary Coverage:

All major systems are covered against Breakdown during the Agreement Term, except those specifically listed under Exclusions.

Covered categories include:

- Engine & Transmission
- Drives (Primary, Final, Secondary, Shaft-Drive)
- Lubricating & Cooling Systems
- Suspension, Steering & Brakes
- Electrical & Charging Systems, Gauges, Fuel & Oil Systems
- Factory-Installed GPS, Radio/CD/DVD Player
- Fluids & Fasteners (related to covered systems)
- Seals & Gaskets: Covered when replaced with a Breakdown repair

Electric Golf Cart Battery

- \$500 Lithium Battery Coverage

Service Call Reimbursement

- Covered claim is eligible for \$100 reimbursement
- Available if owner is unable to transport vehicle to a licensed repair facility

Pickup and Delivery Reimbursement

- Covered claim is eligible for \$100 reimbursement

CART GUARD VSC EXCLUSIONS



Coverage does not apply to:

- **Where/When:** Repairs outside U.S./Canada, not pre-approved, reported late, or not performed as authorized.
- **Causes:** Defects/recalls, accidents, abuse, neglect, poor maintenance, contamination, corrosion, overheating, unauthorized mods, or system hacking.
- **Vehicles:** Salvage/total loss, voided warranties, commercial use, racing, or beyond manufacturer specs.
- **Wear & Tear:** Spark plugs, belts, hoses, filters, fluids, tires, brakes, clutches, batteries, alignments, tune-ups, fasteners.
- **Cosmetic/Non-Essential:** Paint, trim, seats, upholstery, glass, mirrors, moldings, aftermarket electronics, lights/bulbs, exhaust discoloration, winches.
- **Other:** Aesthetic damage, acts of nature/crime (fire, theft, storms, floods), hazardous waste fees, loss of use or rental, consequential damage, pre-existing issues, or gradual wear without failure.

TRANSFERS & CANCELLATIONS

Transfers:

- Only to a new owner (not dealers). Must request transfer within 15 days of sale and provide maintenance records, transfer form, and pay \$50 fee.

Cancellations:

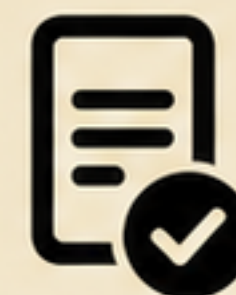
- You: Cancel anytime. Full refund within 30 days (if no claims). After 30 days: pro-rated refund minus \$50 fee and any claims paid.
- Lienholder: May cancel for non-payment, repossession, or total loss. Refunds go to lienholder and are processed through the selling dealer within 30 days.



VEHICLE SERVICE CONTRACT EXCLUSIONS

Our Vehicle Service Contract provides comprehensive protection for many of the major components on your golf cart. The items below are not covered under the contract.

NON-COVERED PARTS & MAINTENANCE ITEMS

Failure of or damage to non-covered parts or regular maintenance items, including:

- Alignments
- Wheel balancing
- Tune-ups
- Ignition inspections



FILTERS, FLUIDS & SERVICE MATERIALS

The following items are not covered, unless required for a covered repair:

- Filters
- Lubricants
- Fluids
- Caulking
- Sealants
- Clips, screws, washers, and fasteners



AESTHETIC & COSMETIC DAMAGE

Aesthetic damage is not covered, including:

- Scratches
- Paint deterioration
- Dents
- Fading
- Environmental damage
- Upholstery wear and tear



IMPORTANT NOTE

If a non-covered part or maintenance item is required in connection with a covered repair, it may be covered by the contract.
